Unfortunately, whomever shared this information with you did not share an accurate accounting. The following is what occurred (documentation is attached):

- March 27, 2023, Ms. Emily Owen, Director of Operations for Congressman DeSaulnier's Office reached out and requested that the District set up a "Listening Tour" during school hours.
- This included a request for District staff to convene the Congressman's stakeholders (including members of the Workforce Development Board, the Chamber of Commerce, etc).
- This request would entail hours of District time and effort.
- I contacted one of our attorneys about the request to ensure that this was advisable.
- He stated that using District resources for one politician/elected official would commit the
  District to ensuring the same resources were used for other politicians/elected officials and
  that there seemed to be a greater benefit to the Congressman politically than to the
  educational benefit of our students.
- I respectfully responded to Ms. Owen that we would be declining at this time.
- On or around April 24<sup>th</sup>, Mr. Aaron Sanchez, District Representative for Congressman DeSaulnier contacted Deer Valley High School directly with the same request.
- The principal declined participation.
- I reached out to Mr. Sanchez to share what I previously shared with his colleague and declined participation.
- Velma Wilson, community member, called to advocate for Mr. DeSaulnier's visit.
- I shared our position with Ms. Wilson who then asked if the Congressman was invited by a government teacher to share information about the government and the three branches of government would that be permissible. I responded that it would.
- The Congressman and Ms. Scales-Preston arrived at Deer Valley May 1st.
- The office called the teacher whom they stated they were there to see. The teacher stated that he was told by Ms. Velma Wilson that the Congressman was coming to speak to his class

(he does not teach government and he did not invite him).

- The principal shared that his understanding was that the teacher had not invited him and that they had been told that the District was not participating in the "Listening Tour."
- Ms. Scales-Preston stated that they had permission from Ms. Velma Wilson.
- The Principal stated that Ms. Wilson is not an employee of the District and does not have the authority to grant such permission.
- The Congressman and Ms. Scales-Preston came to the District office and requested a meeting shortly after.
- I was in interviews and could not meet at that time.
- My office contacted Ms. Scales-Preston that same day to arrange a meeting.
- Ms. Scales-Preston declined and stated she would call back to schedule a meeting.
- Later that day I also contacted Ms. Scales-Preston by email.
- I have not received a response.

If the Congressman or any elected official would like to meet with their constituents on our school sites, they are welcome to fill out a use permit to do so. However, District staff cannot expend resources on one elected official without allowing all elected officials to benefit similarly if requested. Additionally, if an elected official is invited by a government teacher, etc. to talk about the government, etc. that is also permissible.

I will be sharing this information with the rest of the Board so that everyone has the same information.



# Good morning,

Unfortunately, whomever shared this information with you did not share an accurate accounting. The following is what occurred (documentation is attached):

- March 27, 2023, Ms. Emily Owen, Director of Operations for Congressman DeSaulnier's Office reached out and requested that the District set up a "Listening Tour" during school hours.
- This included a request for District staff to convene the Congressman's stakeholders (including members of the Workforce Development Board, the Chamber of Commerce, etc).
- This request would entail hours of District time and effort.

- I contacted one of our attorneys about the request to ensure that this was advisable.
- He stated that using District resources for one politician/elected official would commit the District to ensuring the same resources were used for other politicians/elected officials and that there seemed to be a greater benefit to the Congressman politically than to the educational benefit of our students.
- I respectfully responded to Ms. Owen that we would be declining at this time.
- On or around April 24<sup>th</sup>, Mr. Aaron Sanchez, District Representative for Congressman DeSaulnier contacted Deer Valley High School directly with the same request.
- The principal declined participation.
- I reached out to Mr. Sanchez to share what I previously shared with his colleague and declined participation.
- Velma Wilson, community member, called to advocate for Mr. DeSaulnier's visit.
- I shared our position with Ms. Wilson who then asked if the Congressman was invited by a government teacher to share information about the government and the three branches of government would that be permissible. I responded that it would.
- The Congressman and Ms. Scales-Preston arrived at Deer Valley May 1st.
- The office called the teacher whom they stated they were there to see. The teacher stated that he was told by Ms. Velma Wilson that the Congressman was coming to speak to his class (he does not teach government and he did not invite him).
- The principal shared that his understanding was that the teacher had not invited him and that they had been told that the District was not participating in the "Listening Tour."
- Ms. Scales-Preston stated that they had permission from Ms. Velma Wilson.
- The Principal stated that Ms. Wilson is not an employee of the District and does not have the authority to grant such permission.
- The Congressman and Ms. Scales-Preston came to the District office and requested a meeting shortly after.
- I was in interviews and could not meet at that time.
- My office contacted Ms. Scales-Preston that same day to arrange a meeting.
- Ms. Scales-Preston declined and stated she would call back to schedule a meeting.
- Later that day I also contacted Ms. Scales-Preston by email.
- I have not received a response.

If the Congressman or any elected official would like to meet with their constituents on our school sites, they are welcome to fill out a use permit to do so. However, District staff cannot expend resources on one elected official without allowing all elected officials to benefit similarly if requested. Additionally, if an elected official is invited by a government teacher, etc. to talk about the government, etc. that is also permissible.

I will be sharing this information with the rest of the Board so that everyone has the same information.
