**COUNT 1 – CRIMINAL THREATS**

The undersigned states, on information and belief, that Roy Arceroldan, Defendant, did commit a Felony, a violation of PC422(a), Criminal Threats, committed as follows:

On or about April 24, 2024, in the County of Contra Costa, State of California, the crime of Criminal Threats in violation of PC422(a), a Felony, was committed in that ROY ARCEROLDAN did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to Pleasant Hill Police Chief Scott D. Vermillion, with the specific intent that the statement be taken as a threat. It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to Scott D. Vermillion a gravity of purpose and an immediate prospect of execution. It is further alleged that the said Scott D. Vermillion was reasonably in sustained fear of his/her safety and the safety of his/her immediate family.

**COUNT 2 – ANNOYING TELEPHONE CALLS**

The undersigned states, on information and belief, that Roy Arceroldan, Defendant, did commit a Misdemeanor, a violation of PC653M(a), Annoying Telephone Calls, committed as follows:

On or between February 24, 2024 and April 24, 2024, in the County of Contra Costa, State of California, the crime of Annoying Telephone Calls in violation of PC653M(a), a Misdemeanor, was committed in that ROY ARCEROLDAN did unlawfully, and with intent to annoy, telephone, make contact by means of an electronic communication device and address obscene language to Pleasant Hill Police Chief Scott D. Vermillion, and address threats to inflict injury to the person of and the property of the Pleasant Hill Police Department.

**COUNT 3 – ANNOYING TELEPHONE CALLS**

The undersigned states, on information and belief, that Roy Arceroldan, Defendant, did commit a Misdemeanor, a violation of PC653M(a), Annoying Telephone Calls, committed as follows:

On or about April 19, 2024, in the County of Contra Costa, State of California, the crime of Annoying Telephone Calls in violation of PC653M(a), a Misdemeanor, was committed in that ROY ARCEROLDAN did unlawfully, and with intent to annoy, telephone, make contact by means of an electronic communication

device and address obscene language to Contra Costa County Supervisor Ken Carlson, and address threats to inflict injury to the person of and the property of Supervisor Ken Carlson.

Complainant requests that the Defendant[s] be dealt with according to the law.
